The Anniversary Giveaway 2025

General Rules

- 1. Nightingale House Lottery's monthly Anniversary Giveaway is open to all mainland Great Britain residents over the age of 18 (this excludes Northern Ireland, Isle of Man, Channel Islands and British Forces Post Office addresses according to the Gambling Act 2005 regulations) and who are actively in the Nightingale House Lottery.
- 2. There is no requirement to purchase a ticket for the Anniversary Giveaway. Each lottery member (not lottery numbers) will be automatically entered into the Anniversary Giveaway.
- 3. All prizes for the monthly Anniversary Giveaway will be donated by local companies, businesses or individuals. The next prize available will each be advertised and promoted following the previous months prize winner.
- 4. Winners might be asked if they wish to take part in Nightingale House Hospice PR and promotional activity.
- 5. Nightingale House Hospice is registered with the Gambling Commission to operate the Lottery and Super draws, under licence number 005112-N-304077-015 and ancillary remote licence 005112-A-330219-002.
- 6. Prize draws are not regulated by the Gambling Commission (though they do have some published guidance on the topic due to the perceived similarity to lotteriesthe interest from the Gambling Commission is primarily to ensure that prize draws are not run as illegal lotteries). There is no reporting requirement to the Gambling Commission, even if the entry criteria are based on lottery support.

Rules

- 1. One Anniversary Giveaway entry is granted to each active Nightingale Lottery member at the time of the monthly draw (15th). Should a lottery membership be cancelled/lapse or become dormant on this date of the month, you will not qualify for the Birthday Prize Giveaway.
- 2. Anniversary Giveaway will happen on the 15th of each month. Should the 15th fall on a Saturday or Sunday, the draw will take place on the Friday before the 15th.
- 3. The Anniversary Giveaway will only be held during the year of 2025, as Nightingale House Hospice celebrate 30 years of Hospice care in the community.
- 4. Winners will be notified by telephone. If we are unable to contact the winner by telephone, we will write to them asking then to contact the Lottery Team. Should the prize not be claimed by the end of the month the draw is applicable to, the prize will be donated back to Nightingale House Hospice fundraising team or Lottery team

to generate additional funds for the hospice. Prizes will be delivered within the county of Wrexham, outside of this area, collection may be requested.
